TERMS AND CONDITIONS

The member will accept and be bound by the Terms and Conditions relating to membership of Four Seasons Hotel Bahrain Bay Spa.

1. GENERAL INFORMATION

- SINGLE MEMBERSHIP must be the legal age of 18 years with passport copy/CPR copy as proof of age.
- b. COUPLE MEMBERSHIP must be the legal age of 18 years, certified married couple with proof of marriage certificate.
- FAMILY MEMBERSHIP must be the legal age of 18 years, certified married couple including maximum two (2) children from age 3 to age 17.
- d. The acceptance of a membership is at the sole discretion of the Management of Four Seasons Hotel Bahrain Bay. The management membership committee reserves the right to accept or refuse any membership application or renewal without explanation or reason given.
- These Rules and Regulations will bind the members and their quests; non-compliance may lead to membership termination.
- MEDICAL EXAMINATION Future members are advised to undergo a medical examination at their own cost prior to joining the Spa membership to ensure health and well-being.
- g. CANCELLATION OF TREATMENTS AND FITNESS PROGRAMS Four Seasons Hotel Bahrain Bay reserves the right to stop or cancel any treatment or fitness program of a member when it is considered to become a risk to the member's well-being and safety.
- h. OPERATIONAL CHANGES Four Seasons Hotel Bahrain Bay reserves the right to change the operation times of the Spa, pool, locker facilities and Fitness Centre, including and not limited to the repair and maintenance program of the facilities at any time without notice. This may include complete closure of the facility if the Hotel is directed by the Government to secure the whole estate for a security-sensitive event.
- ACCIDENTS AND RESULTING INJURIES Four Seasons Hotel Bahrain Bay is not responsible for any accidents, resulting injury, illness and/or mental impairment of any member, caused or aggravated by any prior injury or illness of the member, whether known or unknown, through the use of the facilities.
- j. VALIDITY OF SPA MEMBERSHIP The membership is valid for the duration of the chosen period, either three or six months or one year, and is non-transferable and non-refundable. Four Seasons does not allow membership to be held beyond its expiry date or the expiry date to be moved.
- k. MEMBER'S IDENTIFICATION CARD It is mandatory that the Member's Identification Card be presented to the Spa Reception upon arrival and collected upon departure. It is understood that the membership card is non-transferable and cannot be used by anyone other than the member whose name is stated on the membership card. Four Seasons Hotel Bahrain Bay reserves the right to cancel the membership should the member fail to honour this rule. The loss of a membership card must be communicated immediately to Four Seasons Hotel Bahrain Bay Spa for replacement. Membership cards are the property of Four Seasons Hotel Bahrain Bay.
- CANCELLATION OF MEMBERSHIP Four Seasons Hotel Bahrain Bay reserves the right to cancel a membership, including the refunding of fees at its sole discretion at any time without notice. Grounds for cancellation include, but are not limited to, a member's violation of the pre-set Terms and Conditions.
- m. RENEWAL OF MEMBERSHIP Renewal of the membership is at the sole discretion of Four Seasons Hotel Bahrain Bay, and the renewal fee must be paid in full one month before the membership expiration.
- n. MEMBERS' CONDUCT Members are expected to conduct themselves in an appropriate manner, respecting the dignity and rights of fellow members and the Hotel staff.
- o. CORPORATE MEMBERSHIP ACCOUNTS The Corporate Spa Membership rates offered to a company are based on a minimum of five memberships per year. Productivity will be monitored after one year. Should productivity fall below the agreed membership rate, the Hotel reserves the right to renegotiate the agreement.
- SUSPENSION OF MEMBERSHIP A member may suspend annual membership for a period of one month. Suspension requires a written notice by the member to the Spa Management.

2. USE OF THE SPA. POOL AND FITNESS CENTRE

- a. Only Four Seasons Hotel Bahrain Bay Spa members, Spa guests and Hotel guests may use the facilities and services of Four Seasons Hotel Bahrain Bay Spa.
- b. Members using the Spa, pools, lockers and fitness facilities do so at their own risk and sole responsibility.
- The Hotel accepts no liability for injury, death or loss associated with the use of the Spa, pools, lockers and fitness facilities.
- d. Members will comply with any reasonable request from Four Seasons Hotel Bahrain Bay to ensure the smooth operation of the Spa, pools and fitner control.
- Members will comply with the Spa and fitness centre reservation procedures, age restriction policy and facility usage policy as advised by Four Seasons Hotel Bahrain Bay
- Four Seasons Hotel Bahrain Bay is not responsible for unavailability of services, facilities and/or equipment for whatever reason.
- g. For safety and hygiene reasons, when using any of the Spa, pools, lockers and fitness facilities, members must be respectably and appropriately dressed: otherwise, admission may be refused. Proper swimwear must be worn at all times when using Spa water facilities as well as the pools and beach. Proper sports attire and workout clothing together with sports shoes with non-marking soles must be worn in the Fitness Centre.
- Members are respectfully requested to keep noise to a minimum level and should not use any equipment that will disrupt the privacy, comfort and relaxation of other members.
- Personal trainers/coaches/teachers who are not directly employed by Four Seasons Hotel Bahrain Bay are not permitted to work anywhere within the Spa, pools and Fitness Centre.
- Smoking is strictly prohibited in the Spa, indoor pool and fitness facilities, except for the designated outdoor area.
- k. Mobile phones are strictly prohibited inside the Steam Room,
 Hammam, Salt Inhalation Therapy Room and Whirlpool
- Food and beverages from outside the Hotel may not be brought inside the Spa, pools and fitness facilities for personal consumption.
- m. Pets are not allowed in the Spa, pools and fitness facilities.
- n. No diving, running or eating is permitted in the Pools.
- AGE RESTRICTION Four Seasons Hotel Bahrain Bay has set the following age restriction policy for safety reasons.
- Members 16 years old and above are allowed to use the Spa, pools, lockers and fitness facilities.
- b. Children 12 years old and above are allowed to use the pools and locker facilities if accompanied by an adult.
- Children below 16 years old are strictly prohibited from using the Spa and fitness facilities.

4. SAFETY AND SECURITY

- a. Four Seasons Hotel Bahrain Bay is not responsible for any loss or theft occurring within the premises of the Spa, pools, fitness and locker facilities. Members are encouraged to safeguard their personal belongings in their selected lockers and to ensure their lockers are properly locked.
- Parents are at all times responsible for the behaviour of their children and must accompany their children under 16 years old while using the Family Pool and changing rooms.
- c. All nannies must be fully registered on the membership application form under 'Membership Extension'. All nannies will be given access cards to gain entry to the Spa. Nannies are not permitted to use facilities under any circumstances. Nannies are welcome to participate in Kids For All Seasons with the family member's children. The management of Four Seasons Hotel Bahrain Bay reserves the right to change these Terms and Conditions with or without prior notice if it is felt to be in the interest of the membership to do so.
- I have read and understand the above terms and conditions for membership at Four Seasons Hotel Bahrain Bay Spa and agree that I and/or family members/guests will co-operate and abide by the Rules and Regulations whilst in Four Seasons Hotel Bahrain Bay Spa, pools and fitness premises.
