SHARED TRANSFERS ON FOUR SEASONS 'FLYING TRIGGERFISH' (8-SEAT LUXURY AIRCRAFT)

Rates are quoted in USD per person, per way and are subject to 23.2% service charge and GST. Children under two years of age travel free of charge on a guardian's lap.

Shared transfers are scheduled within two hours of check-in.

Private charters are scheduled seamlessly and include CIP immigration and luggage service for up to 8 passengers at Velana International Airport's exclusive lounge.

(Note: Private charter correspondence is honoured up to 30 minutes past scheduled arrival/departure time of commercial or private aircraft.)

There is a complimentary baggage allowance of 20 kg checked and 3 kg carry-on luggage. Depending on aircraft load, luggage may be carried on a separate flight. Excess luggage is chargeable at USD 5 + 23.2% service charge and GST per kg.

If the Four Seasons 'Flying Triggerfish' is not available due to technical and scheduling reasons or unforeseen circumstances, alternative arrangements will be offered on another equivalent luxury aircraft or standard aircraft, in which case regular transfer rates will be charged.

Seaplane transfers are available during daytime hours only.

Same-day cancellation and no-show incur full one-way charges.
